3 PUBLIC FORUM

3.1 Bicycle Nelson Bays - Bevan Woodward and – safe and appropriate speed limits

A PowerPoint presentation was provided, which is available on Council's website in the Minutes Attachments Document. Mr Woodward spoke in support of cycle safety, about speed limits, sustainability and affordability, high vehicle use and rural and urban roads. He asked that Tasman District Council adopt the safe and appropriate speeds of option D for urban and option 4 for rural, in the Speed Management Plan.

3.2 Patrick Shortley – the continuing issues of road safety in Ngatimoti

Mr Shortley spoke about the Speed Management Plan and the timeframe of completion and his concerns around road safety in Ngātīmoti. He asked that Council undertake a sensible risk assessment and consider priority being given to the 100km stretch outside Ngātīmoti School.

7 REPORTS

7.1 Draft Regional Land Transport Plan 2024-34 and Draft Regional Public Transport Plan 2024-34 - Draft for Consultation

Group Manager Infrastructure, Alec Louverdis and Contractor Transport Activity Management, Rhys Palmer took the report as read and noted key points regarding the mid-term review stage, removal of Marlborough, updated maps, legislative timeframes, the government policy statement, financial value and the increase from \$5 million to \$15 million.

Mr Palmer noted the following amendments to the recommendation:

 Clause 4 was separated into two separate clauses and additional sub-clauses 4 (a) and 5 (a) were added.

Mr Louverdis and Mr Palmer answered questions.

Action: NZTA/Waka Kotahi to provide a brief regarding the reason for the Hope Bypass

cost escalation.

Action: Emission reduction and sustainability – an additional paragraph to be added

around position on infrastructure to support this and recognition that the topic will

be considered.

Action: Golden Bay – add additional wording 'to work with commercial providers'.

That the Joint Nelson Tasman Regional Transport Committee

- 1. receives the Draft Regional Land Transport Plan 2024-34 and Draft Regional Public Transport Plan 2024-34 Draft for Consultation report and its attachments; and
- approves the use of the special consultative procedure for community consultation on the Draft Regional Land Transport Plan (Attachment 1 to the agenda report) and the Draft Regional Public Transport Plan (Attachment 2 to the agenda report); and
- 3. approves_the change in the significance policy contained with the Draft Regional Land Transport Plan (Attachment 1 to the agenda report) with the substantive change being an increase in the financial limit from \$5M to \$15M; and
- 4. adopts the Draft Regional Land Transport Plan (Attachment 1 to the agenda report), with the following amendment:

- a) amend the draft Regional Land Transport Plan to include all 'committed transport activities' and 'regionally significant expenditure from other funding sources' in the relevant tables; and
- 5. adopts the Draft Regional Public Transport Plan (Attachment 2 to the agenda report) as the Statements of Proposal for the purposes of the special consultative procedure, with the following amendment:
 - a) amend the draft Regional Public Transport Plan to reflect the role the Nelson Tasman Community Transport Trust provides in providing community transport and support the Councils provide for this; and
- 6. adopts the Summary of the Statements of Proposal (Attachment 3 to the agenda report) to enable public understanding of the proposal; and
- 7. approves the consultation approach (set out in sections/paragraphs 4.20 4.25 and Attachment 4 to the agenda report and agrees:
 - (a) the approach meets the requirements of the Land Transport Act 2003, including Section 125, accounting for the fact that the Joint Regional Transport Committee has delegated authority to develop the draft Regional Public Transport Plan from Nelson City Council and Tasman District Councils, both unitary authorities; and
 - (b) the approach includes sufficient steps to ensure the Statements of Proposal will be reasonably accessible to the public and will be publicised in a manner appropriate to its purpose and significance; and
 - (c) the approach will result in the Summary of the Statements of Proposal being as widely publicised as is reasonably practicable as a basis for consultation; and
- 8. delegates authority for any minor word changes to the consultation documents to the Chair and Deputy Chair of the Joint Nelson Tasman Regional Transport Committee.
