NELSON DISTRICT LICENSING COMMITTEE ANNUAL REPORT – 2015/2016

In accordance with Section 199 of the Sale and Supply of Alcohol Act 2012 the Nelson District Licensing Committee (DLC) submits their Annual Report for 2015/2016 as follows:

1. Overview of DLC Workload

DLC Structure and Personnel

Two new members joined the District Licensing Committee in 2015/16, otherwise membership has remained the same in 2015/16 since their appointment in November 2013. Members include:

Staff Training

The Licensing Inspector attended the annual NZILLI (Institute for Licensing Inspectors) Conference in Dunedin in September 2015. The conference is an annual professional development opportunity attended by Licensing Inspectors, Police, Public Health Service staff and Health Promotion Agency staff working in the alcohol harm reduction area.

DLC Meetings and Hearings

It has been a busy year for Temporary Authorities with the DLC meeting to consider 21 applications.

A hearing was scheduled for August 2015 to consider off and on licence renewal applications by Washing Machine Services Limited for the Victory Liquor Centre. The application received 31 objections and was opposed by the reporting agencies. The applicant subsequently withdrew the applications and has not sought to apply for new licences for the premises.

A hearing was scheduled for December 2015 to consider a special licence application for a primary school gala event that was opposed by the Medical Officer of Health. Subsequently the parties were able to come to an agreement about the arrangements for the event and the hearing was not required.

A new off licence application for a bottle store was opposed by the Medical Officer of Health on the grounds that the applicant had not sought to designate the premises as supervised or restricted. Subsequently this opposition was withdrawn and the off licence was granted with no designated areas.

All other decisions have been unopposed and granted on the papers by the Commissioner.

Monitoring and Compliance

159 monitoring and compliance visits were made during the year with these being a combination of daytime inspections, after-hours compliance checks and Controlled Purchase Operations.

Four Controlled Purchase Operations were conducted during the year with a total of 51 visits to 35 premises. Three alcohol sales to minors occurred – all from on licensed premises.

Five special licences for large events were also monitored during the year. A Controlled Purchase Operation at one of these events resulted in a sale of alcohol to a minor.

A Controlled Purchase Operation focusing on food availability was carried out in conjunction with the Public Health Service. Of the nine premises visited the staff at two the premises failed to promote the available food sufficiently and were issued a warning letter. The remaining seven premises had sufficient food available that was being actively promoted.


Make Up of Licensed Premises

There are currently 38 off licensed premises, 104 on licensed premises and 18 club licensed premises in Nelson. The table below details changes in licensed premises in the last year.



2. DLC Initiatives

Alcohol Licensing Enforcement Group

Nelson continues to be involved in the Alcohol Licensing Enforcement Group (ALEG) for the region with NZ Police, Nelson Marlborough Public Health Service and Tasman District Council meeting once a month. The group has finalised a combined agency agreement which is expected to be adopted early in the 2016/17 year. The agreement covers each agency's role and the approach to licensing activities in the region, including how information is shared, reporting on applications, monitoring and enforcement.

The group continues to produce the "Nelson Tasman Alcohol Update". This publication is provided to all licensees in the region twice a year and includes topical information and updates on licensing matters for licensees, their managers and staff. The update provides a way of providing a consistent message for licensees regarding the expectations of the reporting agencies. The publication is available on the Council website (www.nelson.govt.nz search phrase = host responsibility).

Nelson Tasman Regional Alcohol Accord

Nelson also continues to be involved in the established (2006) Nelson Tasman Regional Alcohol Accord which meets regularly to look at new and innovative ways of dealing with alcohol problems in the community. It involves Police, District Licensing Committees (Nelson and Tasman), Councils, Health, ACC, Ambulance, Hospitality New Zealand and representatives from licensed premises.

Work in 2015/16 focused on developing a new action plan for the activities of the Accord following the review carried out the previous year. Projects are now being programmed and funding sought to implement these.

3. Local Alcohol Policy

There has been no further progress on a Local Alcohol Policy for Nelson since the Council adjourned deliberations on a draft policy in 2014.

4. Current Legislation

The following points are noted in relation to the legislation.

DLC Quorum Requirements

As raised in our report last year - the need for a quorum of three DLC members when considering an unopposed Temporary Authority application or Temporary Licence application under Section 74 - the applicant requirements and granting criteria in these situations are significantly less than a substantive licence which, if unopposed, the Commissioner can grant on the papers alone. We look forward to this situation being aligned so that unopposed Temporary Authority and Temporary Licence applications can also be considered by the Commissioner alone.

Grounds for Objections to New Licence Applications

Section 6 of the Sale and Supply of Alcohol Amendment Act 2015 (2015 No 33) amended Section 102(4) of the Act to the following:

102 Objections to applications

(4) This subsection applies to an application—

- a) for a licence for premises that is of the same kind as the licence currently in force for those premises; and*
- b) in which the conditions sought are the same as apply to that licence.*

(4A) In the case of an application to which subsection (4) applies, the ground for an objection may not relate to any matter other than the suitability of the applicant.

A licence of the same type and with the same conditions can result in a very different operation with very different effects. Objectors (with an interest greater

than the general public) may reasonably feel they can have a say on those matters as well. As an example, a premises that currently has an off licence in force that operates as a tavern and the new licence application for the premises is for an off licence bottle store. Objectors may have grounds in relation to other Section 105 criteria such as amenity and good order.

Repealing sections 102(4) and (4A) would mean objections could be made in relation to all Section 105 matters (as covered by Section 102(3)).

Penalties Where no Manager's Certificate is Held

The most common situation where a person who is not the licensee or the holder of a manager's certificate commits an offence is during a controlled purchase operation (Section 239(2)). In this situation the only option available to seek penalty is conviction through the district court (Section 239(4)). The Act provides an alternative option for the same offence for the licensee or the holder of a manager's certificate by way of a Section 280/285 suspension/ cancellation. This provides an alternative to pursuing a conviction through the courts.

Given that the seller is the employee and holds less responsibility in relation the sale and supply of alcohol (as they are not the holder of a manager's certificate and are not the licensee), the penalty of a conviction and fine for the seller appears disproportionate to the penalty of a licence or manager certificate suspension which does not become a conviction on the person's record.

The introduction of new infringement offence for selling alcohol to a minor for anyone who is not the holder of a manager's certificate or licence holder would address this imbalance.

5. Other Matters

Licence Fees

In March 2016 Nelson City Council adopted additional "particular circumstances" that will qualify for a fee category reduction under the provisions of the Sale and Supply of Alcohol Regulations (Fees) 2013. These are detailed in the table below.

Particular Circumstances	Reason
Off Licence Remote (internet) sales This will apply where the licence holder is selling products they manufacture only	A number of manufacturers (breweries, wineries, distilleries) hold an Off Licence in the very low category to operate a cellar door but also do internet sales. This fee category reduction will ensure all remote sellers are in the same fee category
Off Licence Gift baskets	Very low risk activity
Off Licence Specialty food focus	This relates to specialty food stores where the selection of alcohol is provided as a complement to the food products being sold
On licence premise latest hours until 12 midnight	Reducing the availability of alcohol is a key method in reducing alcohol related harm - fee reduction to incentivise further licence hours reductions
Off licence premise latest hours until 9pm	
Note: Fee reductions are only applied if there are no enforcement holdings
